2.The petitioners apprehending arrest at the hands of the
respondent police for the offences punishable under sections 147,
341, 294(b) and 506(ii) of I.P.C., in Crime No.223 of 2020 on the
file of the respondent police, seek anticipatory bail.

3.Due to communal acrimony, these petitioners have picked

5.Recording the submission of the learned Additional Public Prosecutor, this Criminal Original Petition is dismissed.
