PRAYER:

For Bail in Crime No.158 of 2020 on the file of the Respondent Police.

ORDER : The Court Made the following order :-

This Court on 02.06.2020 in CrI.O.P(MD) No.5505 of 2020 has granted bail to the petitioner on condition to furnish sureties subject to the satisfaction of the learned Judicial Magistrate No.II, Sattur before release.

2. The learned counsel for the petitioner has requested this Court through E-mail to modify the said conditions since the learned Judicial Magistrate No.II, Sattur is unable to accept sureties inview of Covid lock down.

3. Considering the said request, the order passed by this Court on 02.06.2020 is *suo motu* modified:

"Accordingly the petitioner is ordered to be released on bail on his executing own bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) subject to the satisfaction of the Superintendent, Sub Jail, Thirupathoor and on further condition that the petitioner herein shall execute a bond for a sum of Rs.25,000/-with two sureties within 21 days from the date of release to the satisfaction of the learned Judicial Magistrate Court No.II, Sattur".

4. All other conditions imposed by this Court in the said order shall stand remains.
