3.to conduct the inspection in the presence of the petitioner, Bharathi, W/O.Pandi, and also the third respondent, V.Chandrakala, The Executive Officer, Thiruppuvanam Town Panchayat, Sivagangai District / her officials

4.You are further informed that the initial remuneration for the Commissioner is fixed as Rs.5,000/-(Five Thousand only)and any other expenses incurred by the Advocate Commissioner may also be borne by the petitioner herein.

5.The report may be forwarded through e-mail to the Registrar Judicial, Madurai Bench of Madras High Court, Madurai on or before 15.06.2020.
