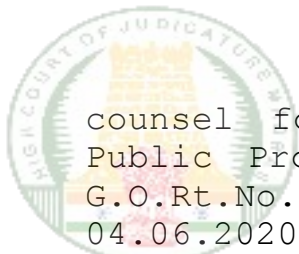

The petitioner has filed the habeas corpus petition seeking to quash the proceedings of the second respondent in M.H.S.Confdl No.26/2020 dated 16.04.2020 branding the detenu viz., the petitioner, Shanmugathai, aged about 42 years W/o Arunachalam, as a "Goonda" as contemplated under Section 2(f) of Tamil Nadu Act, 14 of 1982, detained her at the Special Prison for Women, Madurai and to set her at liberty.
