PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

To release the petitioner on bail in the event of his arrest in Cr.No.690 of 2020 on the file of the Respondent Police pending investigation.

ORDER : The Court made the following order :-

Heard the learned counsel appearing for the petitioner and the learned Government Advocate(Crl. Side) appearing for the respondent.

2. The petitioner apprehending arrest at the hands of the respondent police for the offences under section 379 of I.P.C., and Section 21(1) of Mines and Minerals (Development and Regulation) Act, 1957, in Crime No.690 of 2020, on the file of the respondent police, seeks anticipatory bail.

3.The petitioner illegally transported quarter unit of sand.

4.Taking note of the facts and circumstances of the case, anticipatory bail is granted with certain conditions. The petitioner undertakes to deposit a sum of Rs.7,500/- (Rupees Seven Thousand Five Hundred only) as non refundable deposit to the credit of Crime No.690 of 2020, before the jurisdictional Court. It will be without prejudice to the petitioner's defence in the trial. The said amount
