Prayer in WP(MD). 7110/ 2020:

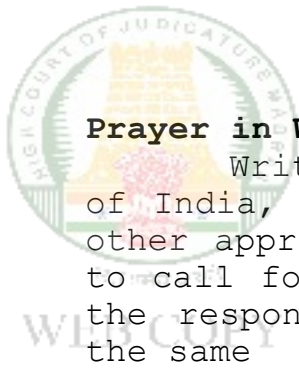
