PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

To enlarge the petitioner/accused on bail in the event of his arrest in WLOR No.1 of 2020 on the file of the respondent police and thus render justice.

ORDER : The Court made the following order :-

Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

2.The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under sections 21(d), (e), (f), (h) and Section 51, 53 of the Tamil Nadu Forest Act and Section 9, 21(1), 27(1), 29 of the Indian Wild Life Act, 1972 in W.L.O.R.No.1 of 2020 on the file of the respondent police, seeks anticipatory bail.

3.It is seen from FIR that the petitioner has pounced deer in the reserved forest area and deer meat also recovered from the house
