2.In view of the above submission made by the learned counsel for the appellants, this Criminal Appeal is dismissed as withdrawn. No Costs.

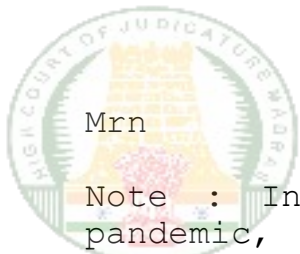
