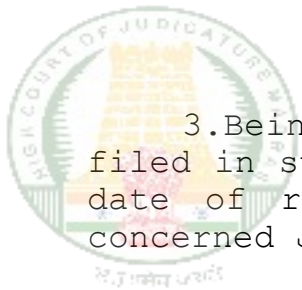
Prayer in CRL OP(MD). 4555/ 2020 :
