ORDER

The accused had undertaken to pay a sum of Rs. 6,00,000/- at the time of obtaining anticipatory bail. Alleging that his undertaking has been dishonored, this contempt petition came to be filed.

2. Previously, a sum of Rs. 4,00,000/- had been paid. The learned counsel for the accused is ready with the demand draft for a sum of Rs. 2,00,000/-. The learned counsel for the contemnor states that the accused will pass on a sum of Rs. 2,00,000/- vide demand draft to the learned counsel for the petitioner by today itself.



3. Since the undertaking has now been complied with, the contempt petition can be closed. The contempt petition stands closed. I make it clear that the payment of this amount of Rs.6,00,000/- to the petitioner will not in any way prejudice the defence of the accused.
