PRAYER :-

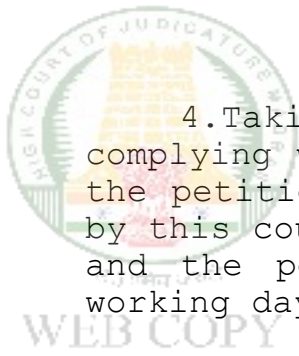
