PRAYER :-

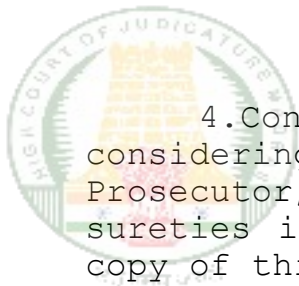
to extend the time for production of sureties in Crl.O.P.(MD) No.5455 of 2020, dated 26.05.2020 on te file of this Court.
