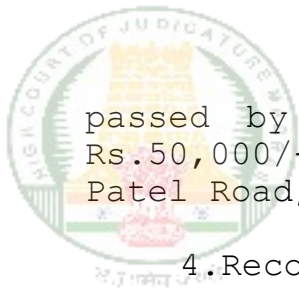
ORDER : The Court made the following order :-
