Prayer in CRL RC(MD). 136/ 2020 :

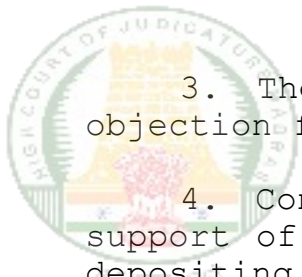
