2.The learned counsel for the petitioners seeks time to produce sureties. Since there was a difficulty in arranging the sureties, the petitioners are unable to execute the sureties within the stipulated time as per the order of CrI.O.P(MD) No.3359 of 2020 dated 25.02.2020.



3. In view of the same, time granted by this Court vide order dated 25.02.2020 in CrI.O.P(MD) No.3359 of 2020 is extended till 21.07.2020.
