Since the petitionr is unable to mobilize the amount, he seeks two weeks time to deposit the said amount.



3. Considering the request, time granted by this Court vide order dated 17.06.2020 in Crl.O.P(MD) No.6154 of 2020 is extended by two weeks from today for executing sureties and surrender before the concerned Magistrate Court
