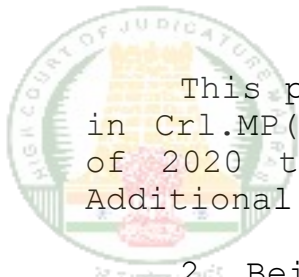
Prayer in CRL MP(MD)NO. 3516 OF 2020 :-
