2.This Court, by an order dated 08.07.2020 in Crl.OP.(MD)No.7118 of 2020, granted anticipatory bail to the petitioner on condition that the petitioner shall deposit a sum of Rs.10,000/- to the credit of Cancer Institute (WIA), No.38, Sardar Patel Road, Adyar, Chennai-20, within a period of one week from 09.07.2020.

4.Considering the facts and circumstances of the case, this petition is closed and time is granted to the petitioner to deposit a sum of Rs.10,000/- to the credit of Cancer Institute (WIA), No.38, Sardar Patel Road, Adyar, Chennai-20 and to execute the sureties within a period of two weeks from today.
