4.Recording the aforesaid submission, this petition is closed.

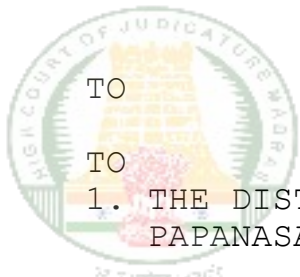
