3.Recording the above submission of the learned counsel for the petitioner, this Habeas Corpus Petition is closed.

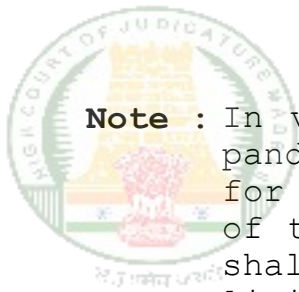
