2.The learned counsel for the petitioner would submit that earlier this Court by an order, dated 03.06.2020 granted anticipatory bail to the petitioner on condition to surrender before the concerned Court within a period of 15 days. He would further submit that the petitioner has appeared before the learned Judicial Magistrate No.2, Dindigul along with two sureties and the learned Magistrate has refused to accept the sureties on the ground that the petitioner has produced a web copy of the order.



3. Considering the rival submission, time granted by this Court vide order dated 03.06.2020 in CrI.O.P(MD) No.5494 of 2020 is extended by two weeks from today.
