The learned counsel for the petitioner would submit that earlier this Court by an order, dated 23.03.2020 granted anticipatory bail to the petitioner on condition to surrender before the concerned Court within a period of 15 days. During the total lock down period, he could not appear before the concerned Court and produce the sureties.



3. Considering the request, time granted by this Court vide order dated 23.03.2020 in Crl.O.P(MD) No.5086 of 2020 is extended by two weeks from today.
