PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

This matter is listed today under the caption '**for reporting compliance**'.

2. This Court, while granting anticipatory bail to the petitioners vide order dated 20.07.2020, imposed a condition to the effect that they shall jointly deposit a sum of Rs.25,000/- [Rupees Twenty Five Thousand only] to the credit of Cancer Institute (WIA), No.38, Sardar Patel Road, Adyar, Chennai-20, within a period of one week without prejudice to their rights and contentions before the Trial Court.

3. When the matter was listed 'for reporting compliance' on 29.07.2020, the learned counsel for the petitioners requests one week time to comply with the said order. Considering the request made, the petitioners were granted time till **05.08.2020** to comply with the said condition.



4. When the matter came up for hearing today (06.08.2020), the learned counsel for the petitioners submitted that the said condition has been complied with. The said submission is, hereby, recorded and no further order is necessary in this petition.
