Prayer in WP(MD). 6204/ 2020 :

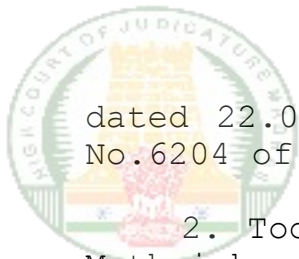
