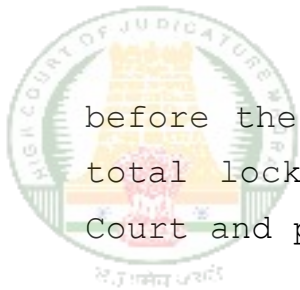

2.The learned counsel for the petitioner would submit that earlier this Court by an order, dated 17.06.2020 granted anticipatory bail to the petitioner on condition to surrender



before the concerned Court within a period of 15 days. During the total lock down period, he could not appear before the concerned Court and produce the sureties.
