4.The learned Additional Government Pleader appearing for the respondents would submit that the petitioner's representation dated



23.10.2019 would be considered on merits and in accordance with law, within a time frame to be fixed by this Court.

5. In agreement with the submission made by the learned Additional Government Pleader, without expressing any opinion on the merits of the case, this Court directs the 4th respondent to consider the petitioner's representation dated 23.10.2019 and pass appropriate orders on merits and in accordance with law, after affording due opportunity of hearing to the petitioner and the interested parties, if any, within a period of twelve weeks from the date of receipt of a copy of this order.

6. This Writ Petition is disposed of, with the above direction. No costs.
