This Court, by order dated 25.06.2020, in Crl.O.P.(MD)No.6594 of 2020, directed the petitioner to appear before the learned Judicial Magistrate, Andipatti with two sureties, within a period of fifteen days from the date on which the order copy made ready. According to the petitioner, due to lock down owing to COVID-19 pandemic situation, the petitioner was unable to appear before the Magistrate concerned with two sureties, within the stipulated time and hence, the present petition has been filed seeking extension of time.



2. Considering the facts and circumstances of the case, time granted by this Court vide order dated 25.06.2020 in Crl.O.P.(MD) No.6594 of 2020 is extended by two weeks from today.

3. Accordingly, this Criminal Miscellaneous Petition is ordered.
