The learned counsel for the petitioner would submit that earlier this Court by an order, dated 15.07.2020 granted anticipatory bail to the petitioner on condition to deposit a sum of Rs.10 Lakhs to the credit of Crime No. 270 of 2020 before the learned Judicial Magistrate, Tenkasi, on or before 22.07.2020 and he is further directed to deposit the remaining amount of Rs.18 Lakhs on or before 07.09.2020. Due to the reason of closing of Bank, he is unable to deposit before the concerned Magistrate Court.



3. Considering the request, time granted by this Court vide order dated 15.07.2020 in Crl.O.P(MD) No.6939 of 2020 is extended by one week from today.
