In view of the COVID-19 pandemic situation the failure of the petitioner, to comply the condition from 05.07.2020 to 11.07.2020, is condoned and the condition imposed by this court in Crl.M.P.(MD)No.3288 of 2018 on 12.02.2020, is modified to the effect that the petitioner shall report before the concerned Court at 10.30 a.m. on the first working day of every English Calendar month, pending disposal of the appeal. This petition is allowed accordingly.
