Due to lock down owing to COVID-19 pandemic situation, the petitioner is not able to get a copy of RC book to produce and also surrender before the Court concerned with two sureties. Hence, the petitioner seeks extension of time by filing the present Miscellaneous Petition.

2. Considering the facts and circumstances of the case, time granted by this Court vide order dated 01.07.2020 in Crl.O.P.(MD) No.6878 of 2020 is extended by two weeks from today.



3. Accordingly, this Criminal Miscellaneous Petition is ordered.
