2.The learned Additional Advocate General states that the tender process has already been over and the work order was issued on 15.07.2020. He further states that the work has already been started and it progress to some extent also. Therefore, the question of granting an order of interim injunction does not arise. Hence, the interim injunction application is dismissed. However, the rejection order passed by the authority has to be examined.
