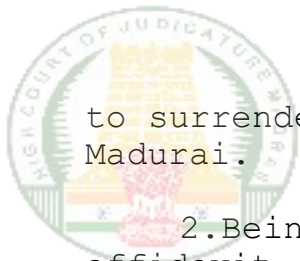
Prayer in CRL OP(MD). 5423/ 2020 :
