2.The learned counsel for the petitioners would submit that earlier this Court by an order, dated 16.03.2020 anticipatory bail to the petitioner with a condition to deposit Rs.25,000/- by way of Demand Draft in favour of the Chairman/District Collector, District Mineral Foundation Trust. He would further submit that though the petitioners have deposited the said amount, during the lock down period, they could not appear before the concerned Court and hence could not produce the sureties.
