For Bail in Crime No.1127 of 2020 on the file of the respondent police.

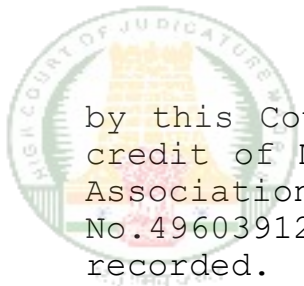
ORDER : The Court made the following order :-
