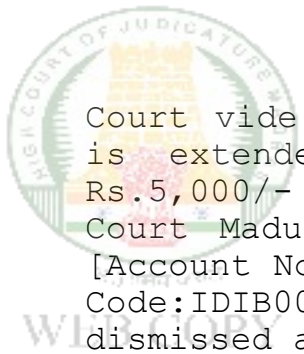

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.M.BENAZIR BEGUM, Advocate for the petitioners and of MR.K.SUYAMBULINGA BHARATHI, Government Advocate (Crl.Side) on behalf of the Respondent, the court made the following order:-

This Court, by order dated 05.06.2020, in Crl.O.P.(MD)No.5708 of 2020, directed the petitioners to appear and execute a bond for a sum of Rs.25,000/- [Rupees Twenty Five Thousand only] before the learned Magistrate, Thirumayam, Pudukkottai District, on or before 03.07.2020. According to the petitioners, due to lock down owing to COVID-19 pandemic situation, the petitioners were not able to move from Pudukkottai to Thirumayam, within the stipulated time and hence, the present petition has been filed seeking extension of time.
