3. According to the learned Government Advocate (Criminal Side), the petitioners are complying with the condition imposed by this Court regularly.

4. Considering the fact that the petitioners are regularly



complying with the conditional order, the condition already imposed on the petitioners is, hereby, modified to the effect that the petitioners shall report before the respondent police once in a week, i.e., on every Monday at 10.30 a.m., until further orders.

5. This Criminal Miscellaneous Petition is ordered accordingly.
