2.On the side of the petitioner, it is stated that initially this Court has passed a conditional order on 28.01.2020, directing the petitioner to appear before the learned Sessions Judge, Fast Track Mahila Court, Nagercoil twice a day at 10.30 a.m., and 05.00 p.m. Later the condition was modified on 27.02.2020 to appear daily at 10.30 a.m., until the further orders. It is stated that the petitioner is complying the condition till now and prayed the condition to be relaxed.

3.On the side of the prosecution, it is stated that the petitioner is complying the condition till now.



4. In view of the submissions made by both the counsel, this Court is inclined to relax the condition imposed by this Court in Crl.M.P.(MD)No.122 of 2020 in Crl.A.(MD)No.368 of 2019 dated 28.01.2020. Hence, this petition is allowed.
