Prayer: Writ petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the first respondent herein to conduct a detailed enquiry into the complaint given by the petitioner dated 18.07.2020 against the third respondent by following the provisions of Section 205(1)(a) of the Tamil Nadu Panchayats Act 1994 and to remove the third respondent from the post of President of Vembattur Panchayat, Sivagangai District of the Tamil Nadu Village Panchayat Act within the time stipulated by this Court.

The first respondent will look into the allegations made by the petitioner herein and pass appropriate orders in accordance with law within a period of sixteen weeks from the date of receipt of a copy of this order.
