2. This Court, by an order dated 19.02.2020 in CrI.OP.(MD) No.2928 of 2020, directed the petitioner to appear before the learned Judicial Magistrate, Theni on 29.04.2020 and to file a petition to recall the warrant.

3. The learned counsel appearing for the petitioner would submit that at that time the petitioner was in Malaysia and due to pandemic situation there is no flight service to come to India and hence, he was not able to surrender and file a petition to recall the Non-bailable warrant.

4. Heard the learned Government Advocate (criminal side) appearing for the respondent police. .
