This Court, by order dated 11.06.2020, in CrI.O.P.(MD)No.5996 of 2020, directed the petitioners to appear before the learned Judicial Magistrate Court, Thiruppuvanam, Sivagangai District, each with two sureties, within a period of eight weeks from the date on which the order copy made ready. According to the petitioners, due to lock down owing to COVID-19 pandemic situation, the petitioners were unable to appear before the Magistrate concerned with two sureties, within the stipulated time and hence, the present petition has been filed seeking extension of time.

2. Considering the facts and circumstances of the case, time granted by this Court vide order dated 11.06.2020 in CrI.O.P.(MD) No.5996 of 2020 is extended by two weeks from today.
