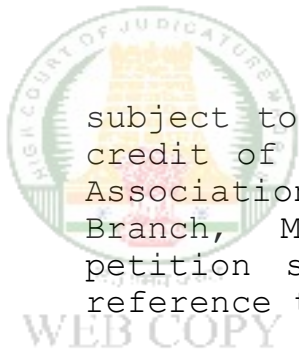

Side) on behalf of the Respondent, the court made the following order:-

Earlier, this Court, by order dated 22.07.2020, in Crl.M.P.(MD).No.3671 of 2020 in Crl.O.P.(MD)No.5853 of 2020, extended the time to the petitioner to surrender before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready.

2.However, according to the petitioner, due to lock down owing to COVID-19 pandemic situation, the petitioner was not able to appear before the Magistrate concerned, within the stipulated time and hence, the present petition has been filed seeking extension of time.

3.Considering the facts and circumstances of the case, this Criminal Miscellaneous Petition is ordered and time granted by this Court vide order dated 22.07.2020 in Crl.M.P.(MD).No.3671 of 2020 in Crl.O.P.(MD)No.5853 of 2020 is extended by two weeks from today,
