3. The learned Government Advocate states that in this case, First Information Report has been registered in Crime No.8 of 2020 on the file of the third respondent and the vehicle has also been produced before the jurisdictional criminal Court in RPR No.148/2020 dated 18.03.2020.

4. Therefore, the petitioner has to necessarily move the jurisdictional criminal Court for release of the vehicle. On such application being filed by the petitioner, it shall be disposed of within a period of two weeks thereafter. Giving such liberty to the



petitioner, this writ petition stands dismissed. No costs.
