4.It had been further stated that the petitioner can approach the "E-Sevai Maiyam" to workout his remedy, by way of filing a fresh representation along with relevant documents.



5. In reply, the learned counsel appearing for the petitioner requested before this Court that liberty may be given to the petitioner to seek his remedy, by way of filing a fresh representation along with relevant documents before the "E-Sevai Maiyam".

6. Recording the submission made by the learned counsel on either side, this Writ Petition is disposed of with such liberty. No costs.
