The petitioner has filed the habeas corpus petition seeking to quash the proceedings of the second respondent in P.D.O.No.19/2020 dated 12.07.2020, branding the detenu viz., her son, Gunal @ Guna son of Sekar aged about 19 years, as a "Goonda" as contemplated under Section 2(f) of Tamil Nadu Act, 14 of 1982, detained him at the Central Prison, Trichy and to set him at liberty.
