This Court, by order dated 07.05.2020, in Crl.O.P.(MD)No.4860 of 2020, directed the petitioners to appear and execute a bond for a sum of Rs.25,000/- [Rupees Twenty Five Thousand only] before the learned Judicial Magistrate No.III, Nagercoil. According to the petitioner, due to lock down owing to COVID-19 pandemic situation, the petitioner was not able to appear before the Magistrate concerned, within the stipulated time and hence, the present petition has been filed seeking extension of time.
