2.When the matter is taken up for hearing, the learned counsel appearing for the petitioner submitted that the petitioner had preferred an appeal before the Revenue Divisional Officer on 23.08.2020.

3.The learned Additional Government Pleader appearing for the respondents submitted that since the matter is pending before the Revenue Divisional Officer, the petitioner has to workout her remedy before the appellate authority and further submitted that nothing survives for adjudication in the present Writ Petition.

4.Recording the submissions made by the learned counsel appearing on either side, this Writ Petition is dismissed as infructuous. However, the petitioner has to workout her remedy before the appellate authority. No costs. Consequently, connected Miscellaneous Petitions are closed.
