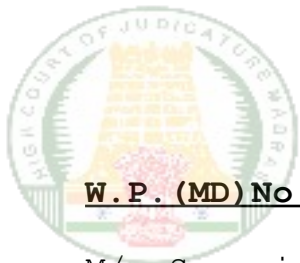

If the petitioners commit default, the order now passed will stand withdrawn automatically and it is open to the respondent to take action as per law.

3.The writ petitions are disposed of accordingly. No costs. Consequently, connected miscellaneous petitions are closed.

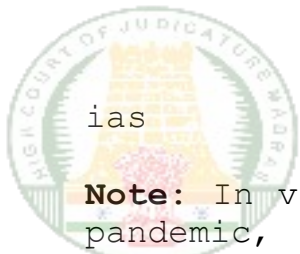
