The learned counsel for the petitioners would submit that earlier this Court by an order dated 08.07.2020 granted anticipatory bail to the petitioners on condition to surrender before the concerned Court within a period of four weeks. Since copy of the order was made available on 13.07.2020, they are not in a position to appear before the concerned Court and produce the sureties. Hence, they seek two weeks time to deposit the said amount.
