PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory bail in Crime No. 299 of 2020 on the file of the respondent police

ORDER : The Court made the following order :-

The petitioner, who is arrayed as A2, apprehending arrest at the hands of the respondent Police for the offences punishable under Sections 341, 283, 294(b) and 506(ii) of IPC, in Crime No.299 of 2020 on the file of the respondent Police, seeks anticipatory bail.

2.The learned counsel appearing for the petitioner submitted that earlier, this Court, by order dated 01.07.2020, in Crl.O.P. (MD).No.6904 of 2020, granted anticipatory bail to the petitioner, wherein the petitioner was directed to appear before the Jurisdictional Magistrate Court and execute sureties within a period of four weeks from the date of receipt of a copy of that order. However, due to Covid-19, the petitioner was unable to execute the sureties directed by this Court. Hence, the present petition has



been filed.

3.Considering the facts and circumstances of the case and also considering the fact that this petition for anticipatory bail is not maintainable, as the petitioner has already been granted anticipatory bail on 01.07.2020. Accordingly, this criminal original petition is dismissed.
