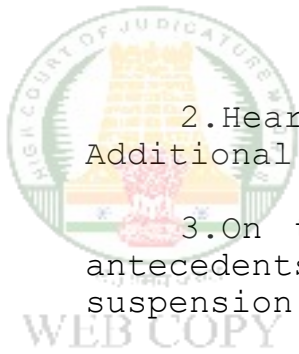
PRAYER IN CRL A(MD) No.453 of 2019:
